Two Essential Principles

Throughout the training, we emphasize two essential principles. They are 1.) the Principle of Informed Choice, and 2.) the Principle of Full Participation, as embodied in the Rehabilitation Act of 1973, as Amended in the Workforce Innovation and Opportunity Act (WIOA).

These principles in the context of a participant-centered service model are a part of our core values and philosophy and are reflected in all steps in the vocational rehabilitation process.

Vital Role of the VR Counselor

This training is part of the Agency's comprehensive effort to strengthen its vocational rehabilitation service delivery system in support of high-quality employment outcomes for people with disabilities. Accomplishing this goal requires a sustained effort on the part of everyone in this agency.

The training combines concepts and policies described in the Rehabilitation Act of 1973, as amended, Federal regulations, State guidelines, and the CRC Code of Ethics as well as research and best practices used in the profession today.

Your Values and Beliefs

It is essential in your role as counselor that you have a clear sense of your personal values and beliefs about persons with disabilities. Your values and beliefs are important for two reasons:

- 1. They define who you are as a VR professional and affect how you will carry out your responsibilities to your participants.
- 2. They will determine your effectiveness toward the achievement of the agency's mission.

The closer your values and beliefs align to those of the agency, the more you will be able to accomplish in serving your participants.
