 - Building a sustainable model for employment in CIE for individuals with significant disabilities including opportunities to grow and advance in employment
 - Individuals currently working in Subminimum Wage
 - Individuals who were recently working or previously employed in subminimum wage who are no longer working
 - Students who are at risk of entering non-integrated settings

 - Will be in Abingdon to present on Able accounts, including a Q and A session, then group can discuss how to tap into able accounts for a wider audience – group agreed that would be helpful

 - Financial Health Overview (this is in addition to the SSA and Waiver services training) separate 4-6 hour Kurtis suggested breaking it down into small increments 6-10 minute, SGA levels change each year so current information and what is SGA and different benefit structures, main questions about ABLE and can they save for retirement; Dave Copeland biggest question is about whether the young person can even work; how can folks become more

- SSA Benefits/ Work Incentives (John: separate SSI and SSDI or is that too confusing?; separate a training for families/individuals outside of the professionals; most families will not understand, bullets on a PP for them
 - David Leon's team felt like this would be a day of 4-6 hours
 - For agency staff -
 - For Parents/Families (Lisa: parents without waiver are very hesitant to try work because if they lose the check they have a hard time getting it back; most of the people she serves who are under 21, the family wants them to work, but once they are older that number drops)
- Waiver services (overview)/benefits DMAS/Arc
 - For Families plain language (how DARS can support with and without the waiver)
- Compassion fatigue/Burnout Managing Secondary Trauma Stress
- Therapeutic/Working Alliance (possibly infused with metacognition)
- No Wrong Door/ Virginia Easy Access training overview and case example, Erika showed the back end of how to connect people with services
